Subject: Amendment in Export Policy of Animal By-Products.

S.O. (E) In exercise of powers conferred by Section 3 of the Foreign Trade (Development & Regulation) Act, 1992 (No. 22 of 1992), as amended, read with Para 1.02 of the Foreign Trade Policy, 2015-20, the Central Government hereby makes the following amendment in the Notification No. 34/2015-20 dated 13.01.2017 with immediate effect, relating to export of Animal By-Products.


2. The existing entries against Sl. No. 41 and 171 of Chapter 5 and Chapter 35 respectively of Schedule – 2, ITC (HS) Export Policy, 2018 shall be substituted as follows:

The Notification No. 34/2015-20 dated 13.01.2017 is amended to the extent that now the "Health Certificate" for items specified under Serial No. 41 and 171 of Schedule 2 of ITCHS Export Policy for export of Animal By-Products will be issued by Export Inspection Council. All other terms and condition of Notification No. 34/2015-20 dated 13.01.2017 will remain the same.
